The last date of receipt of limited tenders is 24.03.2026 up to 11:30 AM after that limited tender documents will not be received by this office and the same will be opened on the same day at 02:30 PM in the presence of the Sub Divisional Magistrate Cum Chairman Temple Trust Shri Naina Devi Ji, Assistant Controller (F&A), Assistant Engineer, Supdt. Grade-I, Supdt. Grade-II, Junior Engineer and Trustee of the Temple Trust Shri Naina Devi Ji as well as tenderers or their authorized representatives who may like to be present at the time. TERMS AND CONDITIONS

1. The limited Tender must be superscripted as "Tender for the electronic items for The office of The Temple Trust Shri Naina Devi Ji. Think Pad- 2Nos, Laptop-i5 1No, Led smart screen 65"inch- 2No. The Rates and GST (as applicable) should be clear.
2. The Limited Tender must be accompanied with an Earnest Money for Rs. 15,000/- (Rs. Fifteen Thousands only) in the shape of FDR duly pledged in favor of the Chairman Cum- Sub Divisional Magistrate Temple Trust Shri Naina Devi Ji, District Bilaspur (H.P) without which tender will be rejected.

3. 100% quantity of material should be supplied & Installed within two weeks.

4. Penalty will be imposed as deemed fit by the undersigned for delay supply and the penalty for late supply will be deducted for the bill of the successful tenderer if he failed to supply the item as per time schedule given Supply Order, However, the penalty can be either waived off or reduced solely at the discretion of the undersigned, if a cogent reason is shown by the tenderer in advance, only for a reasonable period.

5. The Tenderer is required to submit the Bid in a sealed cover along with Tender Form, acceptance of terms & conditions of the tender, undertaking/declaration, attested copies of documents (Valid registration certificate issued by competent authority, TIN No./ PAN/GST No., Aadhar Card/address proof, copy of Partnership Deed in case of Partnership firms mentioned in the terms and conditions. Earnest Money in the shape of FDR duly pledged in favor of the Chairman cum- SDM, TTSNDJI (H.P) shall also be placed in this envelop.

6. Limited Tender should be sent through registered post/speed post/courier /By Hand only to the "Chairman cum- SDM TTSNDJI, Distt. Bilaspur H.P. 174310" In the main envelope separate envelope shall be used for Financial Bid and on the front of the envelope "Financial Bid" shall be clearly mentioned.

7. Conditional tenders will not be entertained.

8. Supplies not confirming to the approved sample will be rejected and returned to the firm at their risk and costs.

9. Company/Partnership firm should not be blacklisted by any state or central Government or any Govt. entity in the last two years. A self-declaration on letter head of the company/firm should be attached (Annexure-A).

10. In case the successful tenderers after having received the supply order from the Chairman cum- Sub Divisional Magistrate TTSNDJI, District Bilaspur (H.P) fails to execute the job, the Chairman cum-SDM will be at liberty to entrust job to other firm/Company at the risk and cost of such failed tenderer. Such failed tenderers will be liable to pay such damages as may claimed by the Chairman cum-SDM TTSNDJI, District Bilaspur (H.P). Such default tenderer shall also be liable to be blacklisted and his security money be forfeited.

11. The Chairman cum- Sub Divisional Magistrate TTSNDJI, District Bilaspur (H.P) reserves the right to accept or reject any tender without assigning any reasons whatsoever.

12. In case of any dispute or difference rising out of regarding the interpretation of any clause of these Terms & Conditions the matter shall be referred for arbitration to the H.P. Govt, whose decision shall be final and binding on both the parties.


13. These terms and Conditions will be treated as an agreement between the undersigned and the successful tenderer/contractor of this tender.


16. All disputes shall be settled within at Himachal Pradesh High Court, Shimla only.
